The "JECA FAIR 2024-72nd Electrical Construction Equipment and Materials Fair," one of Japan's largest general exhibitions of electrical construction equipment, materials, tools and construction methods, will be held for three days from May 29 (Wed.) to 31 (Fri.), 2024, at Tokyo Big Sight East Halls 1, 2 and 3.

First being held in 1957, this year marks the 72nd exhibition.

The event is the largest electrical equipment exhibition in Japan and provides a myriad of information about electrical equipment, tools, instruments, software, construction technology and their performance, as well as academic presentations, various events, and more.

The electrical equipment industry plays a major role in supporting the improvement of people's lives and the sustainable growth of the economy through the construction and maintenance of electrical equipment, such as infrastructure, housing, and office buildings. In addition, the role played by the electrical equipment industry, which includes supporting people's lives and lifelines in the closest places to their lives and providing safety and security, will remain unchanged in the future.






#### Qualifications for exhibitors

- Must be either a corporation engaged in business related to the exhibited items or a related organization or government agency that is recognized by the organizer.
- The executive committee may decline entry to corporations that are eligible to exhibit or that have exhibited in the past if we deem they may have a significant negative effect on visitors and other exhibitors or if they violate the exhibition rules and standards defined in the regulations and manuals concerning the purpose and overall management of this exhibition.





## **Block booths**

These booths are for exhibitors that require a bigger space for the size of exhibits and demonstrations. (Please apply for at least four booths as booths are arranged in multiple rows.)

#### Basic equipment configuration

One or two sides may be adjacent to other companies' booths.

When booths are adjacent to another exhibitor, a 2.7m high dividing panel will be built as a system panel wall. No setback is required if the back wall faces a structural wall (if there are no other exhibitors or passageways). Depending on the size of the exhibits and the exhibition hall, irregular booths may be built.

A booth number card showing the company name is provided.


The space will be made available after the boundary is marked on the floor.

#### 2. Application period

From October 25 (Wed), 2023 to January 19 (Fri), 2024: Note that we may close applications even before the deadline.

#### 3. Priority

Members of this association are given priority for admission. If there is space, applications from nonmembers are accepted on a first-come, first-served basis.

#### 4. Payment of the exhibition fee

Once the application is accepted, the organizer will issue an invoice for the exhibition fee to each applicant. Applicants must send the exhibition fee by January 31 (Wed), 2024 JST. The exhibitor must pay all bank charges.

#### 5. Canceling an application

If an exhibitor wishes to cancel or reduce the number of booth spaces after submitting an application, they must submit a written notice by mail, which will be valid only after it is received by the JECA FAIR Secretariat. In such cases, a cancellation fee must be paid as shown below.

- On or before April 26, 2024 (Fri) JST: 50% of the exhibition fee
- On or after April 27, 2024 (Sat) JST: 100% of the exhibition fee

#### 6. Cancellation and postponement of the exhibition

- The organizer may change, shorten or cancel the exhibition due to an accident, disaster, earthquake, fire, infectious disease, terrorism, or other force majeure. In this case, we will not take any responsibility for the damage caused by the cancellation.
- If the organizer cancels the exhibition due to an accident, disaster, earthquake, fire, infectious disease, terrorism, or other force majeure, the balance of the exhibition fee will be deducted from the exhibitor who has already paid the exhibition fee. The remaining balance will be returned.

In addition, if you do not transfer the exhibition fee, we will charge the expenses up to that point.

#### 7. Responsibility of exhibitors

Exhibitors are requested to take their own measures to respond to damages arising from theft or loss, injury to people or damage to goods, and any other damages.

#### 8. Allocation of booths

The executive committee decides on the allocation of booths taking the product category, weight and size of exhibits, number of booths, the order of the application form accepted and the entire exhibition configuration into consideration. The booth layout will be sent by email around the beginning of March.

#### Online exhibition

An online exhibition will be held on the official JECA FAIR website from May 15 (Wed) 9:00 to June 28 (Fri) 17:00. It will be held as an initiative to support exhibitors at the in-person exhibition. You may not exhibit only at the online exhibition.


#### Venue map



## Exhibition Rules and Regulations

#### Note: It will be assumed that those applying to exhibit have agreed to the exhibition rules and regulations

#### Enforcement of exhibition rules and regulations

Exhibitors must abide by the rules and regulations outlined below and those in the Exhibition Guide. If the Organizer determines that an Exhibitor has violated any rules, the Organizer has the right to, at any time, refuse the application for exhibition or revoke their right to participate, as well as to order the removal of, or changes to, booths, exhibits or decorations. The Organizer's decision and the reasons for such decision will not be disclosed. Moreover, the Organizer will not compensate the Exhibitor or related parties for any damages resulting from advanced payment or any other damages caused by the refusal of an exhibition, or the removal of, or changes to, booths, exhibits or decorations.

#### Eligibility requirements for Exhibitors

- ① Exhibitors must be a corporation engaged in a business related to the exhibited items or a related organization or government agency that is recognized by the Organizer. The executive committee may decline entry in consideration of the purpose and overall management of the exhibition, regardless of whether or not the exhibit application has been accepted, if they are deemed to have a significant negative effect on visitors and other exhibitors or if it violates the rules and standards defined in the exhibition rules and regulations and manuals.
- 2 The Organizer may withhold or refuse applicants from any country or region on the WHO's (the World Health Organization) list of areas designated as transmission areas for infectious diseases. Additionally, at our discretion, we may request related documents or suspend or decline exhibitions of applicants outside the designated countries and regions

#### Application for exhibition and payment of exhibition fee

- ① Exhibitors must submit the exhibit application to the Organizer by mail, by email PDF attachment or through the JECA FAIR 2024 official website. If you are participating in the exhibition for the first time, please attach a company brochure and product catalog to the application. Please remember to make copies of all the exhibit application documents, the exhibition rules and regulations and other material submitted, and store them in a safe place.
- Once the application is accepted, the Organizer will issue an invoice for the exhibition fee to each applicant. Applicants must pay the exhibition fee via bank transfer by January 31(Wed), 2024. If an applicant fails to make payment by the (2) date set by the Organizer, the agreement may be terminated at the discretion of the Organizer.

#### Canceling an application

- Withdrawing from the exhibition, canceling the agreement or reducing the number of booths applied for is not permitted once the application has been  $\bigcirc$ received. However, if an exhibitor is forced, due to circumstances beyond their control, to cancel all or part of their exhibits or cancel the agreement, they must submit the reason for cancellation in writing to the Organizer and pay the cancellation fees stipulated below. The notification of cancellation is effective as of the date upon which the written notice reaches the offices of the Organizer. On or before April 26(Fri), 2024 JST : 50% of the exhibition fee On or after April 27(Sat), 2024 JST: 100% of the exhibition fee
- The refund is to be credited to your bank account with all overseas T/T cable (2) charges and any other transfer fees.

#### Cansellation and postponement of the exhibition

- The Organizer may change, shorten or cancel the exhibition due to an accident, (1) disaster, earthquake, fire, infectious disease, terrorism, or other force majeure. In such cases, we will not take any responsibility for the damage caused by the cancellation
- (2) If the Organizer cancels the event due to an accident, disaster, earthquake, fire, infectious disease, terrorism, or other force majeure, the balance of the exhibition fee will be deducted from the exhibitor who has already paid the exhibition fee. The remaining amount will be returned.

In addition, if you do not transfer the exhibition fee, we will charge the expenses up to that point.

#### **Booth allocation**

- 1 Booth allocation and stock space will be decided by the executive committee after taking into consideration the number of booths, the exhibits and the overall setting. Exemptions regarding the location of booths or any objections by the Exhibitor will not be accepted. The Organizer may at any time change the size or location of exhibitors' booth if the Organizer deems it is necessary for the good of the exhibition.
- The Exhibitor is strictly forbidden from exchanging with, or assigning/leasing out to, other companies or organizations all or part of their exhibition space that has been determined by the Organizer.

#### Submission of documents

After submitting the exhibit application documents, the Exhibitor must deliver the various application forms requested by the Organizer by the designated date. The Organizer reserves the right to decide whether or not to honor any late application.

#### **Rules on exhibition**

- ① If any changes occur in the corporation or organization, or products and other content of the exhibit stated in the application form, the Exhibitor must immediately notify the Organizer in writing.
- The manner in which decorations and exhibits are to be moved in and out of the exhibition site, as well as the exhibition format, shall be prescribed in the Exhibitors' Manual, which the Exhibitor must comply with.
- 3 The Exhibitor is not permitted to engage in any exhibition, advertising, or marketing activities in locations such as the aisles or anywhere other than their own booths. The Exhibitor must not obstruct the activities of neighboring exhibitors. The Organizer will determine, at its sole discretion, what is and is not an obstruction. The Exhibitor must accept this decision and abide by any orders issued by the Organizer.
- (4) Exhibitors must not disturb other exhibitors by giving demonstrations that generate excessive sound, lighting, high temperatures or odor. The Organizer has the right to have any exhibitors stopped, including demonstra-
- tions, if the disturbances are deemed intolerable. Exhibitors must observe all fire and safety regulations for the venue.
- If the Organizer determines any acts to be harmful or disturbing to the visitors or Exhibitors (such as forceful sales practices, solicitation, defamation, interfering with other's marketing activities, etc.) during or after the exhibition period, the Organizer may decide, at its sole discretion, that an exhibit be suspended or that future applications for exhibitions be declined, which the Exhibitor shall comply with.
- 7 The Organizer shall not be held responsible in any way for business discussions or the content of agreements entered into between Exhibitors and visitors during or after the exhibition.
- Each Exhibitor is responsible for restoring the contracted booth area and any parts of the venue damaged when moving in/out to its original condition after the (8) exhibition closes. If the Exhibitor fails to do this, the Organizer will conduct the restoration work and any costs incurred will be charged to the Exhibitor.
- (9) No booth (except your own booth) or article in the venue may be photographed, drawn, copied or reproduced in any way without the permission of the Organizer or the Exhibitor concerned.

#### Rules for the online exhibition


- The following acts are prohibited.
- Acts that interfere with or may interfere with this service
- Acts that infringe or may infringe intellectual property rights, honor, privacy or other rights or interests of third parties
- Acts that directly or indirectly benefit antisocial forces
- Other acts that the Organizer deems inappropriate

#### Regarding the handling of personal information

- (1) The Exhibitor must, in the event that any personal information is acquired through the exhibition, strictly observe the Act on the Protection of Personal Information and related laws, and acquire it in a legal and suitable manner. Exhibitors are requested to publicize and give notification of the purposes for which it will be used, and act within that scope. In particular, Exhibitors, must without fail, obtain the consent of those concerned in the event before personal information is passed on to third parties.
- With regard to the personal information acquired through exhibiting, etc., Exhibitors are requested to strictly observe the secure handling of information stipulated by law, and manage and carry out its handling in an appropriate manner.
- In the event that any complaints or accusations are made regarding the disclosure, alteration, addition, deletion, cessation or removal of usage of personal information acquired through the exhibition by the Exhibitor, the Exhibitor must strictly observe the relevant laws and act in an appropriate 3 manner.
- 4 In the event that any conflict arises between the Exhibitor and a party or one claiming to be a party to which the personal information acquired, handled or managed through the exhibition belongs, the Exhibitor and the concered party will be asked to take steps to resolve the dispute between themselves. The Organizer shall take no responsibility whatsoever in such an event.

#### Damages

- 0 The Organizer will not be held responsible in any way for any damages to persons and/or properties arising for any reason from the use of the exhibition space by the Exhibitor, its employees or associates. The Exhibitor must provide immediate compensation for any damages to the
- structures or equipment in the exhibition hall and nearby area that are a result of carelessness on the part of the Exhibitor's employees, related parties or agents.
- 3 In the event that a dispute with a third party arises concerning the products exhibited or services, the Organizer will accept no responsibility whatsoever. The Exhibitor must resolve and deal with any such expenses and responsibilities, without causing any trouble whatsoever to the Organizer. If any damage etc. is suffered by the Organizer as a result of such a conflict, the Organizer must immediately be compensated.
- (4) The Organizer reserves the right to change the dates and/or the venue of the exhibition or to cancel the entire event if the opening or running of the exhibition is prevented by reason of natural disasters, strikes or any other cause not within the control of the Organizer, but will provide no damages to the Exhibitor or its associates
- The Organizer will not compensate the Exhibitor for any damages arising from 15 disasters, public transportation delays or social unrest.
